

Present=Frank Tranor, Karen Edwards, Brandon Hartman, Carl and Marilyn Kishbaugh and Joey Sue Laubach No members absent.

Meeting came to order at 6:02. Correction noted for spelling by Karen to September minutes, spelling will be corrected. Karen made the motion to elect Carl Kishbaugh Vice-President due to do not have one currently, and Frank seconded. Motion approved for Carl elected Vice-President. Brandon made a motion for meeting minutes to be accepted with changes and Karen seconded. Motion approved.

Financial status- \$3000.00 in PayPal transfer, \$25.00 deposited from previous show, \$192.00 cash handed to Frank at meeting by Brandon for a table for performance and patrons didn't want to use PayPal. Check made out to Brandon at meeting for \$303.50 for rights and scripts for 4 nights and an extra \$18.90 for another script totaling \$322.40. Production acct= \$5122.46, General acct=\$4888.91, Total=\$10,011.37

Brandon stated the domain name for the website must be updated and the total is \$16.99. He also requested an extra \$10.00 for ads on Facebook due to he placed a \$25.00 ad to reach more people. Karen made a motion and Marilyn seconded. Motion approved.

Karen brought in receipts for Rain suits=\$29.98, Mustaches and beards=\$63.58, Fishing nets=\$20.10 and Grey crepe hair=\$7.95 with the total coming to \$121.61. Motion to approve made by Brandon and seconded by Marilyn. Motion approved and check written out to Karen.

PRODUCTION=Brandon is working on a proof for the ads in the newspaper which will run on Sunday October 16 and 23. We also are waiting for North Side Beat in the newspaper which will be story worthy due to Vo-tech catering. Ticket sales end October 31st and currently we have sold out over 50%. Brandon has sent an apology letter to the Old Filling Station stating we are partnering with Vo-Tech but will keep her in mind for the future.

Currently we are not open to Sunday November 6th sales for the play however when sales cover over 75% we will open up Sunday sales. Currently Fridays aren't selling well and we have 60% sold on November 4th, 6 seats left on November 5th, Opened for November 11th and 70% sold for November 12th. We should hear back from Joseph Edmundson from Vo-Tech by the end of this week to finalize and approve the menu and Brandon will send out a formal invitation on email to let patrons know the menu.

Karen talked to Jon White-Spinner last week and emailed Michael from BTE to get in touch about furniture but has not heard back yet.

Frank brought up the subject of program ads and will see if he can sell any within the next two weeks.

Danielle from N4C invited us to the Gala on October 22 as her guests however due to all members have previous plans we need to respectfully decline but appreciate the invitation.

Meeting adjourned at 6:40. The next meeting will be on November 15 instead of November 8 due to in between weeks of play production. Time and place remain the same.
